## Livelihood and Food Security



Different Livelihood Promotion programs have been implemented in Jamshedpur, Potka, Patamda and Boram blocks of East Singhbhum district and in Chandil, Ichagarh, Nimdih and Kukru blocks of Seraikela-Kharsawan district that benefited more than 1000 families. Under these WADI, NON WADI and WATERSHED Program, plantation of different fruit-bearing trees, social forestry plants, seasonal and off season vegetable cultivation, promotion of cereals-pulses and oil seeds, promotion of tuber crops, promotion of spice crops, promotion of creeper crops especially pointed gourd, promotion of floriculture especially marigold and gladiolus, promotion of pisciculture, promotion of small animal rearing especially backyard poultry, duck, goat rearing etc. have been done under the project initiative. Beside project initiatives, convergence with different government schemes of different livelihood programs have also been implemented successfully along with the project activities.

In Gamharia of Seraikela-Kharsawan district, Noamundi of West Singhbhum district in Jharkhand, and Joda of Keonjhar district in Odisha, 167 women including members of 15 SHGs and 10 other individuals were trained on mushroom cultivation and value addition i.e., processing of mushroom for making pickle, soup powder, badi, biscuits, etc. Post training, in last quarter of the financial year 4,247 Kilograms of fresh mushroom of Oyster variety have been produced and sold by the trainees.

In the remote hilltop tolas of Digarda and Lakrakocha of Hesakocha village in Seraikela-Kharsawan district, as follow-up and value addition support to livelihood promotion program of previous financial years, street lighting and Solar Electrification were done benefiting 34 households.

## Agriculture-Horticulture Development

In 7 villages of Dharambahal and Kashidah Panchayats in Ghatsila block in East Singhbhum, women are engaged in floriculture and mushroom cultivation for enhancing household income under RURBAN Mission. Beside establishing linkage with the local market, backyard poultry has been promoted for developing a secondary source of income and increase nutrition sources as egg and meat. Mushroom cultivation training was given to 1200 women beneficiaries In Dudhbilla cluster of Noamundi block of West Singhbhum district in addition to other agri-horticulture development initiatives. Post-training, the beneficiaries have started production at their homes.

During the reporting year, in 15 villages in Potka and Golmuri cum Jugsalai blocks of East Singhbhum district and 10 villages in Chandil block of Seraikela-Kharsawan district, a Lab to Land Program has been implemented. The objectives of this program were to enhance food and nutritional security, as well as improvement of household income. 2500 Farming families were trained in Nutrition Gardening, Cultivation of Commercial Vegetable, Integrated Farming System (IFS), Improved Paddy Cultivation under this program in convergence with different government welfare schemes. In the same area to make the children aware of protection and afforestation, as well as of water conservation, several Environment Awareness programs were conducted for school children of 24 government schools covering 3919 students.

This year, several training programs on cash-crop cultivation, kitchen gardening, duck rearing, floriculture have been organized in Anandpur, Dugni, and Parbatipur villages of Gamharia block, and Dobo and Pudisil of Chandil block in Saraikela-Kharsawan district. This has been done to improve the existing status of household income and nutritional security of 119 farming households and 145 women beneficiaries. Convergence with government schemes and program with 77 families, and handholding support were also done to make this initiative more effective.

A Watershed Development program that had been initiated in the previous financial year, was in full swing at Muru-Jhimri of Nimdihblock and Karka-Sindurpur of Kukru block in Seraikela-Kharsawan district covering 1200 farming families in 4 villages. Activities like new farm bunding (NFB), repair of farm bund (RFB), construction of continuous contour trench (CCT), 3 dobha, 8 new farm ponds (NFP), 5 soil gully plugs, 3 loose boulder structure (LBS), 2 gabian structure, 5 water harvesting structures, 1 concrete nala bundh (CNB) for area and drainage line treatment were done under this initiative. Other than these physical activities, training and exposure visit on kitchen gardening, home-based orchard development, commercial vegetable cultivation, pulses cultivation, integrated farming, small animal rearing, pisciculture etc. were also conducted for capacity building. In effect of these activities,







irrigation water is available in all villages for farming and pisciculture development besides enhancing the soil moisture.

During this reporting period, a WADI development program is being implemented in 6 villages (Salboni, Shilda, Budalong, Patpur, Hutup, Ghatsila) of Ichagarh block of Seraikela-Kharsawan district, covering 500 families (450 small and marginal farmers and 50 landless). Activities like formation of WADI Samity in four villages, plantation in 450 acres of land, putting-up barbed wire fencing, water resources (deep boring) development, awareness generation, field bunding, mulching, intercropping, and training and exposure visit were done. This initiative in continuance to the previous years' interventions, has shown positive impact in the villages of Salboni, Shilda, Budalong, Patpur, Hutup, and Ghatsila. In 450 acres of orchard has been developed that providing additional income to the beneficiaries.

The Farmers Producer Company (FPC) that was formed in previous year in the name and style of Ichagarh Wadi Producer Company Ltd. has remained functional. This company's main objectives are to ensure doorstep supply of farming inputs like seed, seedling, fertilizers and pesticides as well as agri-equipments, provide technical support to farmer to produce maximum crop in a minimum time frame, proper harvesting processing, packaging etc., collect farmers produce from doorsteps and sale in the local and nodal market. In turn, the goal of profit maximization would be achieved.



Since previous year, a project for processing, packaging and marketing of spices crop in Ichagarh block of Seraikela-Kharsawan district under LEDP program was being implemented. Previously formed Swarnarekha Mashala Utpadan Samity has remained functional along with the demonstration unit - grinder machine, weight and packaging machine etc. Training for skill up-gradation, exposure visits, and processing, packaging and marketing of different spices like chilly, turmeric, coriander, cumin seed etc. were organized for the beneficiaries. Presently this Samity is running its business in a quite successful manner. The practice of cultivating spices crops has been increased in the area as a secondary impact of this Samity.

Like previous years, in this reporting period, promotion of cut and loose flower in Patamda and Boram block of East Singhbhum district under another LEDP program. Under this program 150 SHG group members have been trained on scientific cultivation of cut & loose flower, management of flower crops, harvesting, processing, packaging, value addition and marketing of both cut & loose flower. Promotion of floriculture in off-season and marketing of flower in local and nodal markets near Jamshedpur were emphasized. A demonstration unit has also remained functional at Dhusra, Patamda to show all participants and surrounding area farmers how can differently cut & loose flowers produced in a piece of land and floriculture business secured livelihood of a needy family. During this reporting year, huge quantity of cut and loose flower was



produced by 110 farmers for which they earned substantially by selling in the Jamshedpur and surrounding markets.

On 5 acres of land in Uparlota village of Khuntpani block of West Singhbhum district, one integrated farm (multi-layered farm) has been developed and handed over to the tribal beneficiary. The production and marketing have also been started recently.

In Bandhgaon block of West Singhbhum district, under watershed program 4000 beneficiaries have been trained on poultry, duck rearing, fishery, vegetable cultivation etc. and conducted exposure visits for them to KVK – Jagannathpur, ICAR – Palandu, Horticulture College – Khuntpani, and Watershed – Murhu, Khunti.

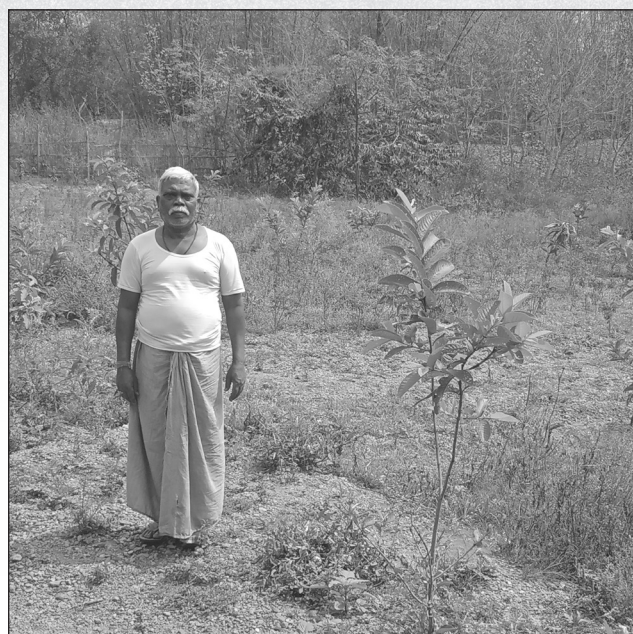
The Mushroom Spawn Production Unit of this organization has produced 57,600 packets of commercial spawn during this reporting year. Besides, in the laboratory, tissue culture and production of mother spawn for Oyster, Milky, Button, and Paddy Straw mushroom varieties were done.

In the districts of East Singhbhum, West Singhbhum, and Seraikela-Kharsawan, five days training were given to 1,100 aspiring mushroom growers and entrepreneurs on techniques of different varieties of mushroom production for commercial purpose.

Training on horticulture development (Bagwan Mitra) for five days has been given to 800 youths in the districts of West Singhbhum and Seraikela-Kharsawan.

One-month Gardener (Mali) Training was conducted at ATMA Bhawan, Chaibasa, West Singhbhum for 23 youth from two districts – West Singhbhum and Seraikela-Kharsawan. These trainees were given certificates by the Agriculture Skill Council of India (ASCI) / NSDC on successful completion of the training and examination.

Since the year 2012, a model nursery called “Subarnarekha Model Nursery” in Rudia at Chandil block of Seraikela-Kharsawan district, is being



run by this organization as its own initiative. It has 5 hectares of land under it. Like previous years, it produced good quality of fruit plants, saplings, seedlings, and vermi-compost for orchard development and plantation in and around this area. Unfortunately, during this year the plants and trees in this nursery severely affected by the roaming elephant herd.

## Education Promotion



In 81 Anganwadi centers in Kukru block of Seraikela-Kharsawan district, TRCSC has tried to ensure quality pre-school education in this financial year. Efforts have been made for strengthening village health, sanitation and nutrition days (VHSNDs), and routine immunization (RI) by motivating Anganwadi Workers (Sevika) and the parents. The left-out, drop-out, resistant (LODOR) families were remained in the center of focus.

For the children from classes I to V, in Kukru, Ichagarh, Nimdih, and Chandil blocks of Seraikela-Kharsawan district, 61 Village Learning Centers (VLC) were being run to compensate learning loss during the lockdown period. Model question papers for classes VII, IX, and X were used in those centres for practice and mock tests on different subjects.

In this reporting year, for the students belong to classes from VIII to XII, Career Counselling & Guidance and linkages with different vocational skill were done in 5 blocks e.g., Chandil, Gamharh, Ichagarh, Kukru, and Nimdih. Throughout the reporting year, science experiments for the students of classes from VI to X in government schools in Chandil, Ichagarh, Kukru, and Nimdih were being done for promoting conceptual clarity and foster scientific interest and temperament among them. This has been done under Multi-dimensional Learning Space (MDLS) program.

## Health and Nutrition



In 81 Anganwadi Centers (AWCs) of Kukru block in Seraikela-Kharsawan district, regular health check-ups, referral services, nutrition education and immunization have been ensured through supporting VHND and celebration of Poshan Month.

During this reporting year, this organization has been promoting backyard nutrition gardening through the women self-help groups and Mahila Mandal to ensure supply and consumption of fresh fruits and vegetables. Under this endeavour more than 720 families in Potka and Jamshedpur blocks of East Singhbhum, and Chandil and Gamharia blocks of Seraikela-Kharsawan district were benefited.

In 8 Kasturba Gandhi Balika Vidyalaya (KGBV) of East Singhbhum district (7) and of Gamharia block in Seraikela-Kharsawan district (1), 75 girl students have been trained in mushroom cultivation and 75 girls in nutrition gardening through learning by doing process in each of these 8 KGBVs. Post training, most of the trainee girls are producing and consuming vegetables at home.

## Women Empowerment



In the villages of Anandpur, Dugni, and Parbatipur of Gamharia block, and Dobo and Pudisili of Chandil block in Saraikela-Kharsawan district, 267 women were organized in village level groups. During this reporting year, these groups have been strengthened by capacity building. At present they are regularly discussing issues relevant to their welfare and raising their voices, whenever required. For enhancing household income, TRCSC has extended handholding support and its technical inputs to these women. As a result, all of these women are now engaged in duck rearing, nutritional gardening, mushroom cultivation, vegetable cultivation, and small businesses.

In Saraikela-Kharsawan and East Singhbhum districts, several women became self-aware and

empowered due to continuous endeavors of TRCSC. In ever-increasing number, these women are taking active part in different community-based committees and social forums, like in the local self-governance system / Gram Sabha and its sub-committees as well as in other forums, such as School Management Committees, Village Child Protection Committees, Village Water & Sanitation Committees, Mata Samiti, and so on.

## Adolescent Empowerment

One of the most important thematic areas of intervention for TRCSC is Adolescent Empowerment. We invest our physical, psychological, as well as technical resources in them as we believe boys and girls belong to the age group of 10 to 19 years are the future of our society. To empower these adolescents, we have organized them in several village level groups. Regular support and counselling are being provided to these groups on the issues related to Child Rights, Protection, Life-skill Education, Menstrual Health and Hygiene (MHM), and entitlements. This program covers Kukru, Gamaria, Ichagarh and Nimdih blocks of Seraikela-Kharsawan district, and Dhalbhumgarh, Ghatsila, Dumaria, Musaboni, Gurabandha, and Potka blocks of East Singhbhum district.

## Child Rights and Protection

Upholding the rights and protection of children are among the most focussed objectives of this organization. It has been running a sub-centre of Childline-1098 at Ghatsila covering Ghatsila, Musaboni, Dhalbhumgarh, Gurabandha, Baharagora, and Dumaria blocks of East Singhbhum district for 24x7 since the year 2015. To cater the entire district of Seraikela-Kharsawan, it has also been working as a collaborative organisation centre in Seraikela town. All these endeavours have been focused on the emergency assistance and child protection, besides monitoring child marriages (CM), child trafficking (CT), and child labour (CL) and awareness generation at the community level through relevant day celebrations and events like ChildLine se Dosti. In this financial year, 398 such cases were handled successfully.

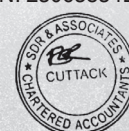
