## Livelihood and Food Security

Since its inception, one of the major thrusts of this organization is on promoting livelihood opportunities for the poor rural population and to work for ensuring round the year food security. In the reporting year, in Jamshedpur, Potka, Patamda and Boram blocks of East Singhbhum district and in Chandil, Ichagarh, Nimdih and Kukru blocks of Seraikela- Kharsawan district, different Livelihood Promotion programs have been implemented. These interventions benefited more than 1200 marginalized families. These endeavours include WADI, NON-WADI and WATERSHED programs, plantation of different fruit-bearing trees, social forestry plants, seasonal and off season vegetable cultivation, promotion of cereals-pulses and oil seeds, promotion of tuber crops, promotion of spice crops, promotion of creeper crops especially pointed gourd, promotion of floriculture especially marigold and gladiolus, promotion of pisciculture, promotion of small animal rearing especially backyard poultry, duck, goat rearing etc. Efforts have also been done to bring in convergence with various government schemes for promotion of livelihood. This was done to make the program outcomes sustainable.

In the last financial year 8,991 Kilograms of fresh mushroom of Oyster variety have been produced and sold by 167 women including members of 12 SHGs, who got the training on mushroom cultivation in Gamharia of Seraikela-Kharsawan district, Noamundi of West Singhbhum district in Jharkhand, and Joda of Keonjhar district in Odisha. These trainees have also been oriented on processing of mushroom for making pickle, soup powder, badi, biscuits, etc. besides mushroom production.

Other than the aforesaid training for women, in this Noamundi block of West Singhbhum district, 100 farmers were trained on Mushroom and Cash Crop Cultivation. Relevant inputs and seeds were also given to support these trainees in initiating their cultivation.

## Agriculture-Horticulture Development

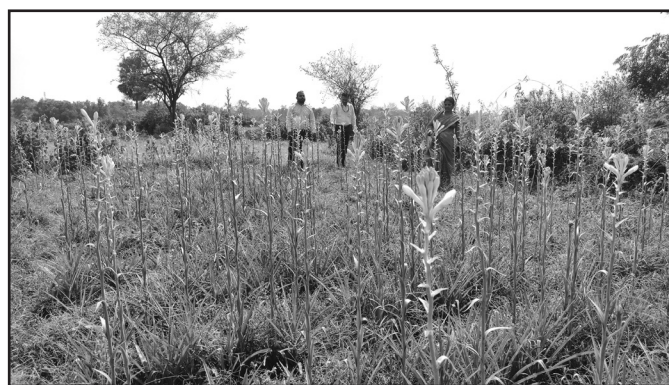
Agriculture and horticulture development is one of the major focuses of TRCSC. As the majority of the population within the intervention areas of this organization is solely dependent on farm activities for their livelihood, it is most essential to work on the development of agri-horticulture and livestock rearing through training on modern scientific techniques as well as quality material inputs. A 'Lab to Land' Program has been implemented in the last financial year with the objectives of this program were to enhance food and nutritional security, as well as improvement of household income. This program was being implemented among the farmers in 14 villages in Potka and Golmuri-cum-Jugsalai blocks of East Singhbhum district and 10 villages in Chandil block of Seraikela-Kharsawan district. Under this program, 2800 farming families were trained in Nutrition Gardening, Cultivation of Commercial Vegetable, Integrated Farming System (IFS), Improved Paddy Cultivation under this program in convergence with different government welfare schemes.

In the same area to make the children aware of protection and afforestation, as well as of water conservation, several Environment Awareness programs were conducted for school children covering 5509 students of 32 government schools in East Singhbhum and Seraikela-Kharsawan districts.



In Anandpur village of Gamharia block, and Dobo and Pudisil of Chandil block in Saraikela Kharsawan district, several training programs on cash-crop cultivation, kitchen gardening, duck rearing, floriculture have been organized in this reporting year. This has been done to improve the existing status of household income

and nutritional security of 65 farming households and 75 women beneficiaries. To make this initiative more effective and sustainable, convergence with government schemes and program for 140 families was done besides providing hand holding support to these program beneficiaries.



Since 2021-22, at Muru and Jhimri of Nimdih block and Karka and Sindurpur of Kukru block in Seraikela-Kharsawan district covering 1649 farming families in 4 villages, a Watershed Development program was being implemented. Under area treatment initiative, activities like construction of new farm bunding and repair of farm bunds, construction of continuous contour trench, new farm ponds, loose boulder structure, water harvesting structures, concrete nala bandh, soil gully plugging were done and under drainage line initiative, activities like concrete nulla bandh, gabian structure etc. were done. Kitchen gardening, home-based orchard development, commercial vegetable cultivation, pulses cultivation, integrated farming, small animal rearing,





pisciculture etc. were also done under climate change initiative. Other than these physical activities, training and exposure visit etc. conducted for skill development.



In 6 villages (Silda, Salbani, Budalong, Hutup, Ghatsila, Patpur) of Ichagarh block of Seraikela Kharsawan district, a WADI development program has been implemented. It covered 450 small and marginal farmers and 50 landless families. Since its initiation in 2021-22, activities like strengthening of WADI Samity in six villages, plantation in 450 acres of land, putting-up barbed wire fencing, water resources (deep boring) development, awareness generation, field bunding, mulching, intercropping, and training and exposure visit were being done. For women and land less families, backyard poultry rearing (40 beneficiaries), duck rearing (15 beneficiaries), goat rearing (90 beneficiaries), pig rearing (5 beneficiaries), fish cultivation (30 beneficiaries) were also implemented. Due to these initiatives, the beneficiaries are able to earn in addition to their previous farm income.



In 10 villages of Patamda and Boram blocks of East Singhbhum, to enhance sustainable income for

poor backward tribal households, a program was implemented benefiting around 500 people. They were trained and involved in different activities of High Value Agriculture (HVA) and Integrated Livestock Rearing (ILR). A Resource Centre has been developed at Dhusra in Patamda where several training activities and demonstration are being done. Beside these, efforts were given to develop water resources for cultivation and to bring in convergence with different schemes.

Under the Watershed program In Bandhgaon and Tantanagar blocks of West Singhbhum district, under watershed program - poultry farming (42), pig rearing (32), goat rearing (76), duck rearing (1316), Dragon Fruit plantation in 1.80 acres of land, and construction of 7 of Poly-houses were done.



During the reporting financial year, several agri horticulture training sessions were organized for the farming community of the three districts, e.g. East Singhbhum, West Singhbhum, and Seraikela-Kharsawan in Kolhan region. A five days training was given to 412 aspiring mushroom growers and entrepreneurs on techniques of different varieties of mushroom production for commercial purpose. Training on horticulture development (Bagwan Mitra) for five days has been given to 420 youths in the districts of West Singhbhum and Seraikela-Kharsawan. A one month Gardener (Mali) Training was conducted at TRCSC Training Centre, Ghoraling, Near Jayada Mandir, Chandil for 75 youth from three districts - East Singhbhum, West Singhbhum and Seraikela-Kharsawan. On successful completion of the training and examination, these trainees were given certificates by the Agriculture Skill Council of India (ASCI)/NSDC. Besides these, training

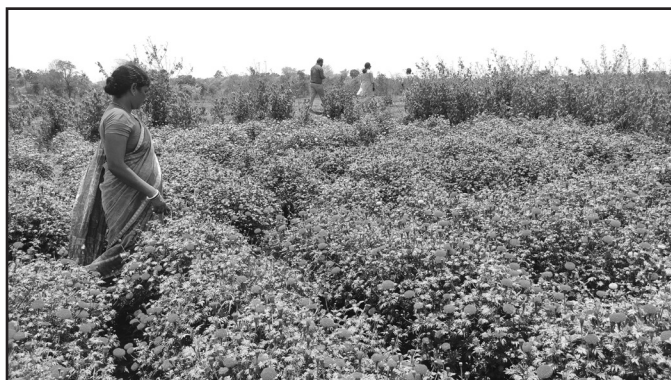


on horticulture development was organized for 700 marginal farmers in West Singhbhum and Seraikela-Kharsawan districts. Exposure visits to see Floriculture development was organized for 50 farmers affiliated to



ATMA, West Singhbhum and Seraikela-Kharsawan, to Padampur, Purba Medinipur, West Bengal.

Ichagarh Wadi Producer Company Ltd., the Farmers Producer Company (FPC) that was formed in the year 2021-22 has remained functional. Its activity includes doorstep supply of farming inputs like seed, seedling, fertilizers and pesticides as well as agriculture equipment, provide technical support to farmer to produce maximum crop in a minimum time frame, proper harvesting processing, packaging etc., collect farm produces from doorsteps and sale in the local and nodal market. Skill development and day to day hand



holding support were also provided to shareholders/farmers.

Other than the project activities, the Mushroom Spawn Production Unit of this organization has produced 62,750 packets of commercial spawn during this reporting year. Besides, in the laboratory, tissue culture

and production of mother spawn for Oyster, Milky, Button, and Paddy Straw mushroom varieties were done. Training on techniques of mushroom cultivation was given to 135 cultivators and small entrepreneurs.

As its own initiative, since the year 2012, Subarnarekha Model Nursery on 5 hectares of land in Rudia at Chandil block of Seraikela Kharsawan district, is being run by this



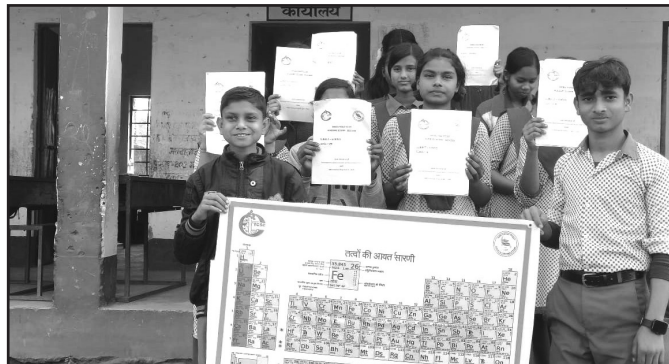
organization. It produced good quality of fruit plants, saplings, seedlings, and vermicompost for orchard development and plantation in and around this area.

## Education Promotion



Promotion of pre-school education and basic quality education for all is one of the most important agenda of this organization. During the reporting financial year, it has given all-out efforts to ensure quality pre-school education at 81 Anganwadi centers in Kukru block of Seraikela Kharsawan district, and developed 10 AWCs as model centres according to the CDF guideline. Besides, efforts have also been given, especially focusing on the Left-Out, Drop-Out, Resistant (LODOR) families for strengthening Village Health, Sanitation and Nutrition Days (VHSNDs), and Routine Immunization (RI) by motivating Anganwadi Workers (Sevika) and the parents.

43 Village Learning Centers (VLC) were being run in Kukru block of Seraikela-Kharsawan district, for the children from classes I to V. In 5 blocks of Seraikela-Kharsawan district e.g., Chandil, Gamharia, Ichagarh, Kukru, and Nimdih Career Counselling & Guidance and linkages with different vocational skill were done for the students belong to classes

from VIII to XII. Throughout the reporting year, science experiments for the students of classes from VI to X in government schools in Chandil, Ichagarh, Kukru, Gamharia and Nimdih were being done for promoting conceptual clarity and foster scientific interest and temperament among them. Model question papers for classes VIII, IX, and X were used in those centres for practice and mock tests on different subjects. This has been done under Multi-dimensional Learning Space (MDLS) program. And in 3 villages of Seraikela-Kharsawan district (Pudisili, Dobo, and Anandpur), Career Counselling, and Training sessions on Life Skills were conducted besides sports materials support.

## Health and Nutrition

As TRCSC believes the health and nutrition are essential part of children's development and protection, throughout the reporting year, regular health check-ups, referral services, nutrition education and immunization have been ensured through supporting VHND and celebration of Poshan Month in 81 Anganwadi Centers (AWCs) of Kukru block in Seraikela-Kharsawan district.

TRCSC has also been promoting backyard nutrition

each of these schools. Most of the trainee girls are producing and consuming vegetables at home, who got the training.



gardening through women self-help groups, Mahila Mandal, and government schools to ensure supply and consumption of fresh fruits and vegetables. Under this endeavour in Potka and Jamshedpur blocks of East Singhbhum, and Chandil and Gamharia blocks of Seraikela Kharsawan district more than 850 families were benefited.

In 9 Kasturba Gandhi Balika Vidyalaya (KGBV) and 2 Jharkhand Abasiya Balika Vidyalaya (JBAV) of East Singhbhum district, 5375 girl students have been trained in mushroom cultivation and in nutrition gardening through learning by doing process in

## Women Empowerment



For empowering rural women, this organization has been working since last three years in the villages of Anandpur of Gamharia block, and Dobo and Pudisili of Chandil block in Seraikela Kharsawan district. In these areas, 75 women were organized in village level groups. These groups have been strengthened through several training for capacity building. Presently, the members of these women's groups are regularly holding village group meetings to discuss issues relevant to their welfare and raising their voices, whenever required. They are also engaged in duck rearing, nutritional gardening, mushroom cultivation, vegetable cultivation, and small businesses. For enhancing household income, TRCSC has extended hand holding support and its technical inputs for livelihood enhancement to these women. Besides this, around 1600 women are also organized in 150 WSHGs in East Singhbhum and Seraikela-Kharsawan districts.

Due to the continuous efforts by this organization, rural women are taking active part in different community-based committees and social forums, like in the local self-governance system / Gram Sabha and its sub-committees as well as in other forums, such as School

Management Committees, Village Child Protection Committees, Village Water & Sanitation Committees, Mata Samiti, etc. in Seraikela-Kharsawan and East Singhbhum districts.

## Adolescent Empowerment

To empower the adolescents within this organization's intervention areas, TRCSC has organized several village and school level groups (ARC/CRC). Regular support and counselling are being provided to these groups on the issues related to Child Rights, Protection, Life Skill Education, Menstrual Health and Hygiene (MHM), and entitlements. Training on Archery and Sewing are also being given to around 330 adolescents in Jamshedpur, Baharagora, Ghatshila, and Musabani KGBVs. TRCSC invests its physical, psychological, as well as technical resources on the adolescents as it believes boys and girls belong to the age group of 10 to 19 years are the future of our society.

## Child Rights and Protection

One of the objectives of utmost importance is to ensure a social environment conducive for the protection and development of all children. Since 2015, TRCSC has been running a sub-centre of Childline-1098 at Ghatsila covering Ghatsila, Musaboni, Dhalbhumgarh, Gurabandha, Baharagora, and Dumaria blocks of East Singhbhum district for 24x7. To cater the entire district of Seraikela-Kharsawan, it has also been working as a collaborative organisation in Seraikela town. All these endeavours have been focused on the emergency assistance and child protection, besides monitoring Child Marriages (CM), Child Trafficking (CT), and Child Labour (CL) and awareness generation at the community level through relevant day celebrations and events like ChildLine se Dosti. In this financial year, around 100 such cases were managed successfully and out of those, 38 children were rehabilitated.

Since January 2024, a program titled SWAYAM, means 'Self' is being implemented in 45 villages of Aruwan, Chhota Segoi, Maranghatu, and Tilopada Panchayat of Kuchai block in Seraikela Kharsawan district. The main goal of this program is to ensure protection of all children and their overall development. In these 45 villages the program covers around 9500 children. To achieve its goal, activities like identification of children at risk through Vulnerability Assessment, Case Management,

organizing children in village level Children's Group (6-10 yrs. & 11-18 yrs.), Work with parents of children in the



age group of 0-6 yrs., Establishing SO Children Resource Centres (CRC) at village level, Training of Peer Educators on issues like Child Rights, Protection, Entitlements, Life Skills, SRHR, and MHM, engaging children through regular training and activities of sports, art and craft, theatre, and creative writing are being done. Special efforts were given on convergence and linkages with state welfare schemes to benefit the target population as well as to sustain the intervention outcomes.

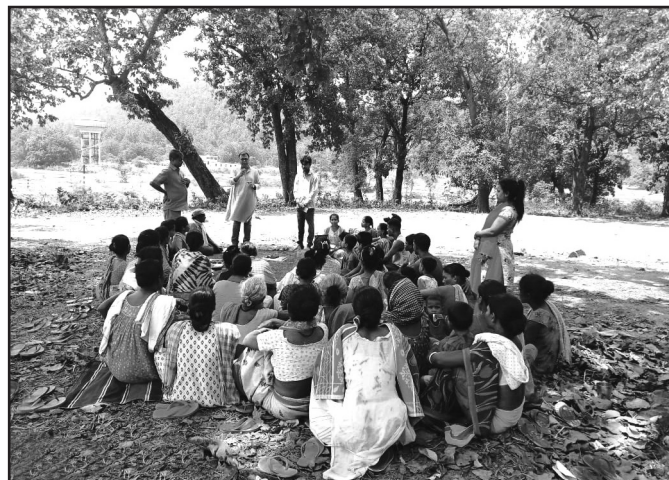
